- 7. All Publication Fees in the National Gazette and the Media is to be paid by the Applicant.
- 8. Your ILG Certificate will be forwarded by registered post, unless you elect to be collected personally by the group Chairman or the Secretary <u>strictly upon presentation of a valid identification card only</u>. Ensure your postal address used in this application, must be reliable.
